

**Bank Guarantee to be submitted by Nodal Training Centres
under Agri-Clinics and Agri-Business Centres Scheme
(To be issued on non Judicial Stamp paper)**

Where as -----(Name and address of the Nodal Training Institute) (herein after called NTI) has executed MOU with MANAGE dated ----- for conducting Training programmes under Agri-Clinics and Agri-Business Centres scheme.

Know all people by these presents that We ----- (Name of the bank) having their registered office at ----- (full address) and Branch at ----- (full address) (herein after called "the Bank") are bound unto National Institute of Agricultural Extension Management (MANAGE) herein after called (MANAGE) in the sum of Rs.2.50 lakhs (Rupees two lakhs and fifty thousand only) for which will and truly to be made to MANAGE, the bank binds itself, its successors and assigns by these presents.

Sealed with common seal of the said bank this ----- day of -----2011.

The conditions of the obligation are:

1. The bank guarantee is in force for a period of five years from the date of issue subject to subsequent renewals.
2. If the NTI withdraw from conducting Agri-Clinics and Agri-Business Centres Scheme training programmes and hand holding support without prior notice to MANAGE.
3. If the NTI discontinues the ongoing Training programme and handholding support in the middle and misuse the scheme funds released in advance by MANAGE.
4. If the NTI does not produce the utilization certificate and accounts as required under the scheme.
5. Does not act or carryout the instructions of MANAGE in respect of conducting Agri-Clinics and Agri-Business Centres Scheme training programmes and handholding support or violate the conditions of MOU executed.
6. False reporting of Data or information on Agri-Clinics and Agri-Business Centres scheme.
7. Non-renewal of Bank Guarantee when demanded by MANAGE
8. Any other act(s) against the interest of Agri-Clinics and Agri-Business Centres Scheme as per the judgment of MANAGE (which shall not be called upon to question under any circumstances).

We undertake to pay to MANAGE without demur up to the above amount (Rs.2.5 lacs) upon receipt of its first written demand from MANAGE, without the MANAGE having to substantiate its demand, provided that in its demand MANAGE will note that the amount claimed by it is due to it, owing to the occurrence of one or all of the above mentioned conditions specifying the occurred condition or conditions.

The guarantee will remain in force for a period of five years or up to the subsequent renewal periods if any and any demand in respect thereof should reach the Bank not later than 60 days after expiry date of the Guarantee. The Bank Guarantee shall be extended for such period as may be required by MANAGE 90 days before expiry of Bank Guarantee.
