Sensitization Workshop for Nodal Training Institutes (NTIs) under the Agri-Clinics and Agri-Business Centres (AC&ABC) scheme





FINANCING INVESTMENT IN VALUE CHAIN INFRASTRUCTURE IN AGRICULTURE AND ALLIED SECTORS

Budget Announcements

- A fund with blended capital, raised under the co-investment model, will be facilitated through NABARD. This is to finance start-ups for agriculture & rural enterprise, relevant for farm produce value chain
- Financing of Development in Value Chain Infrastructure in Agriculture & Allied sectors (Focus Area).
- The provision of a comprehensive package "to help farmers select suitable varieties of fruits and vegetables, and to use appropriate production and harvesting techniques".
- Apart from PLI expansion, food processing sectors, and start-ups, also many small MSME units are the mediums through which employment opportunities are increased. (Focus Area)

Fund with blended capital raised under Co-investment model

- Will follow a hybrid model having both direct and indirect investment components, while also having provisions for extending both equity/debt capital or a blend of both.
- Will be facilitated through NABARD.
- This is to finance start-ups for agriculture & rural enterprise, relevant for farm produce value chain
- To provide equity support to agri-food start-ups and start-ups allied to them (e.g. agri/rural fintech)
- · To nurture and support agri-food tech start-ups in their evolution
- To provide venture debt to agri-food start-ups
- Can be augmented through private sector finance (banks, FIs)

Financing Development in Value Chain Infrastructure in Agriculture

- The changing agricultural environment in India requires a focused approach to develop infrastructure across the value chain
- AIF is launched to provide the required boost to the farm gate and aggregation point infrastructure for Agriculture/Horticulture/Forestry produce
- Objective of AIF is to mobilize a medium long term debt finances facility for investment in viable projects for post-harvest management Infrastructure and community farming assets to improve agriculture infrastructure



Investment in Infrastructure Development of Food Processing Sector

- A special fund of Rs. 2000 crore with NABARD to provide affordable credit to food processing projects/units.
- Rs. 4600 crore Pradhan Mantri Kisan SAMPADA Yojana (PMKSY) credit-linked financial assistance to entrepreneurs for setting up of Mega Food Parks, Mini Food Parks, Food Processing Units, Food Testing Labs, Cold Chains & other Processing & Preservation infrastructure projects.
- Operation Greens (OG) extended from TOP (Tomato, Onion, Potato) to value chain development of 22 perishables under the AtmaNirbhar Bharat Abhiyan stimulus package.

MANAGE-AC&ABC Agripreneurs Webinar Series

The 13th Webinar in the series was organized on February 05th, 2022 at 10:00 am IST. The theme for the webinar was **"Scaling Profits from Integrated and Organic Farming ."**.

Mr. Ranjit B Lende, Programme Coordinator, Krishna Valley Advanced Agricultural Foundation (KVAAF), Nagpur, Maharashtra was the first speaker for the session. He highlighted that the NTI has trained 1,180 candidates in 35 batches. From the trained candidates, 633 candidates have gone ahead and established their own agri-ventures in different categories. The NTI is exhibiting a success rate of 53.65 percent. The NTI has also been instrumental in getting 25+ approval for loan and 13+ approval for subsidies under the scheme. The NTI began operations in 2011 with the goal of training and establishing candidates in the Vidarbha region of Maharashtra, where farmer suicide rates are the highest, thereby bringing about a small change in the agripreneurship ecosystem. The NTI focuses on involving state government agencies and private agribusinesses in order to motivate and expand contacts for their candidates.

Mr. Rohan Y Raut, Founder, Generous Technologies, Maharashtra was the second speaker for the session. He completed his AC&ABC training from KVAAF in 2011 and upon completion decided to quit his previous job and establish his own agri-venture. He stated that he began with 5 indigenous cows, which he used to sell milk and convert cow dung into organic manure. Later on when the cattle number increased to 80, simultaneously Mr. Raut



introduced chicken (Selum and Berad;75 Nos.), Ducks (2 Nos.), Goats (Berari-5, Totapuri-1 Nos.) and Dogs (Carvan Hound-3 Nos.) for protecting the livestock from wild animals. He has also established a bio-fertilizer production unit by the name Generous Technologies Pvt Ltd in Dec 2013 with PGR production and suppling the product in Maharashtra, Karnataka, Chattisgarh and M.P.

Mr. Gajanan Shyamrao Girolkar, Founder, Nagpur Organic Agro Producer Company Ltd. was the third speaker for the session. He has completed the AC&ABC training from KVAAF Nagpur in 2018. Mr. Girolkar has setup the Nagpur Organic Agro Producer Company Ltd. where he has opened many outlets supplying organic produce. Anyone can approach Mr. Girolkar to open an outlet for a deposit of Rs. 2 lakh (Rs. 1 lakh (Refundable) and the remaining Rs. 1 lakh for natural/organic grocery and other food items). He has also founded "Kamdhenu Agro Tech" which is involved in the production and marketing of herbal paste for the protection of orange trees. He mentioned that his future plans include setting up the processing of oil seeds plants with a project cost of ₹16.17 lakh rupees which has been approved by Punjab National Bank, Wardha.
