### NATIONAL AGRIPRENEURSHIP AWRADS (2018-2022)



On occasion of National Youth Day also known as Vivekananda Jayanti was celebrated on 12th January 2023 at New Delhi in a befitting manner by giving National Awards to 82 best Agripreneurs who were trained under the Central Sector Scheme - Agri-Clinics and Agri-Business (AC&ABC) of Govt. of India for their significant contribution to farmers through agri-clinic and agri-business services. On same occasion, 8 Nodal Training Institutes (NTIs) who impart AC&ABC training efficiently also received Awards for their best training, handholding and facilitation activities.



During celebration, dais was presided over by Dr. P. Chandra Shekara, DG, MANAGE together with, Mrs. Shubha Thakur, Joint Secretary, Dr. Sanjay Kumar, Additional Commissioner from the MoA&FW, Gol. ### SESSION I: POLICY REFORMS UNDER AC&ABC Shri Sajith Kumar Kunhalath, Director, MoA & FW

Dr. Shajith extends his congratulations to all of the award recipients and mentions that the Ministry of Agriculture and Farmers Welfare always bringing new initiatives in implementation of the AC&ABC scheme that would benefit Agripreneurs more. Beside, all the stakeholders work together and get benefit of the scheme. In light of the enormous success of the AC&ABC scheme, which is being celebrated today, more unemployed agri-professionals should step up to utilise the advantage of the AC&ABC scheme and launch their own agri-ventures. MoA&FW has always taken the lead in promoting the welfare of Agripreneurs.

### SESSION II: LATEST DEVELOPMENTS IN AC&ABC SCHEME Dr. P. Chandra Shekara, Director General, MANAGE-Hyderabad

Dr. P. Chandra Shekara stated that although we are currently celebrating the success of the AC&ABC scheme, we should not stop here and instead continue on with greater vigour and dedication to propel the AC&ABC towards even greater success. The tripartite partnership between State Bank of India, NABARD, and MANAGE to promote the TSAGROs Raythu Seva Kendram in Telangana State was also highlighted by the Director General. He also spoke about the recent signing of a Memorandum of Understanding with the Mumbai headquarters of SBI to provide financing support to Agripreneurs across the country. The AC&ABC scheme would continue as long as there are State Agriculture Universities in India, Director General concluded.





# SESSION III: PRESENTATION AND DISCUSSION ON RKVY-RAFTAAR (AGRI-STARTUPS)

Dr. Shahaji Phand Principal Coordinator, AC&ABC, MANAGE

Dr. Shahji Phand revealed that, MANAGE-Incubation cetre created one of the largest Agri-Startup ecosystem in India. He appeal to Agripreneurs, bring the new idea of business and get the benefit of the RKVY-RAFTTAR GoI aided scheme. Under RKVY-RAFTTAR scheme incubate doesn't receive the loan but rather a non-refundable grant in four instalments to help him grow his agribusiness. Since product creation to marketing, MANAGE offers all facilities. He also provided a thorough presentation on the RKVY-RAFTAAR scheme.

## SESSION IV: SUBSIDY DISBURSEMENT UNDER AC&ABC SCHEME Ms. Nivedita Tiwary, General Manager, DoR, NABARD

In her presentation, Ms. Nivedita Tiwary, GM, offered her congratulations to all of the award recipients and noted that, today, by looking at the awardee's credentials, she found the fact that the Agripreneur launched their agri-ventures, earning Rs. 1.00 Cr. annually, and provided extension services to more than 1 lakh farmers was evidence that India is marching forward (Bharat Age Badh Raha Hai). Additionally, she says, "Our Culture is Agriculture She concluded by urging that in order to advance the AC&ABC scheme, we must all collaborate holistically. NABARD would provide all required support.

#### **SESSION V: DISBURSEMENT OF LOAN UNDER AC&ABC SCHEME**

Sh. Shantanu Pendse, CGM (ABU&GSS) SBI, Mumbai



The effectiveness of the AC&ABC scheme is demonstrated by today's award ceremony, according to Sh. Shantanu Pendse, who said in his presentation that "Our culture is agriculture." He asked for loud applause from everyone in the audience for this cause. Sh. Pendse reports that MANAGE-Hyderabad and the State Bank of India, Mumbai, have already signed a Memorandum of Understanding (MoU) to provide financial support for aspiring Agripreneurs. Since NTIs are a crucial player in the development of entrepreneurial skills among unemployed agri-graduates, all NTIs have volunteered to work with SBI officials to address the underlying causes of the credit difficulties.

SESSION VI: PRESENTATION AND DISCUSSION ON NHBM

Mr. Naveen Kumar Patale ED, NBB

Mr. Naveen Kumar Patale said that, 75,000 MT honey was exported to USA during 2021-2022. Yet, considering the strength of the Agripreneurs established under the AC&ABC scheme, it is conceivable for the Agripreneurs to engage in a honey beekeeping business in order to export Honey globally. He said, National Beekeeping and Honey Mission (NBHM) Govt. of India has approved a new Central Sector Scheme entitled "National Beekeeping & Honey Mission (NBHM)" for 2 years for overall promotion and development of scientific beekeeping in mission mode to achieve the goal of "Sweet Revolution" in the country. Agripreneurs can browse all of the information on the MoA&FW website. He said.



### SESSION VII: PRESENTATION ON SAMUNNATI Mr. Anil Kumar SG, CEO Samunnati



addressed the group, Mr. Anil Kumar SG highlighting the accomplishments of Samunnati, one of the private agri-financing company that has played a significant role in creating and financing agri-businesses around the nation. Anil Kumar stated that Samunnati has two sectors: the Samunnati Foundation, whose primary function is to help developing Agri-entrepreneurs enhance their capacities, and the Suamnnati Agri-financing Company, which provides loan support to Agri-entrepreneurs. All of the agripreneurs who have been trained and established under the AC&ABC scheme are warmly welcomed by Mr. CEO, and he encourages them to take advantage of Samunnati services in order to take their businesses to the next level of success.

SESSION VIII: PRESENTATION AND DISCUSSION ON ROLE OF AGRIPRENEURS IN ATMA

Shri Balram Singh, Joint Director (Extension Reforms), MoA & FW

In his presentation, speaking to the gathering, Shri Balram Singh said that the celebration today highlighted the important accomplishment of the AC&ABC scheme and that Agripreneur is a revolving agent should not stop here but rather advance the goal of entrepreneurial skill development. India's public extension services were unable to reach the farming community in a timely manner due to a manpower shortage. An Agripreneur can play the role of supplementing the public extension services by partnering with ATMA to provide the public extension services to the doorstep of farming communities. A provision of 10% service charge is available in the ATMA guidelines in the public-private partnership mode.



### SESSION IX: PRESENTATION AND DISCUSSION ON AGRI-INFRASTRUCTURE FUND SCHEME Sh. Amaresh Dey, Execution Lead, AIF PMU



According to Sh. Amaresh Dey, India is self-sufficient in terms of maximum crop productions, but it is difficult to store agricultural products for an extended period of time and provide farmers with real-time prices. The lack of agricultural infrastructure services in India prevents farmers from receiving the full value of the crops they have grown in their fields. Agripreneurs, who are currently engaged in numerous crop production businesses, can benefit from the AIF scheme and boost the profitability of the agri-industry. He gave a thorough presentation on the AIF programme that included showing agricultural activities that could aid agribusiness start-up decisions.

Sh. Manish Saxena, Senior IT Consultant, AIF PMU

The presentation was continued by senior IT consultant Mr. Sh. Manish Saxena. Sh. Saxena said that, Agripreneur can avail dual benefits if they get loan under AIF, Agripreneur can avail subsidy as per AC&ABC standards and all loans under AIF will have interest subvention of 3% per annum up to a limit of Rs. 2 crore. This subvention will be available for a maximum period of seven years. He gave a real-time analysis on how the AIF portal was working. To help Agripreneurs avoid hassle, Shaxena offers helpful advices when submitting applications online using the AIF portal. At last Saxena said Agripreneurs come forward and take benefits of AIF scheme.



Dr. P. Chandra Sekhara, Director General of MANAGE Hyderabad, felicitated with memento to honor of all the speakers. Standing ovations were given during the Indian Anthem at the conclusion of the National Agripreneruship Awards Ceremony.

#### MANAGE-AC&ABC Agripreneurs Webinar Series

The 24th webinar was organized on January 7th 2023 at 10:30 am IST. The theme for the webinar was "Farm Mechanization and Farmers Producer Organization: Reforming the Country's Farming Pattern & Ensuring Food Security".

The ACABC-Team gave a hearty welcome to all participants from India's 9 states before the webinar began. Mr. Dattatray Gosavi, Nodal Officer of KVAAF-Pune, led the opening session.

Since 2013, MANAGE Hyderabad and The Krishna Valley Advanced Agricultural Foundation, Pune, have worked together to implement the AC&ABC Scheme. A total of 30 training programmes have been held thus far, and 1009 unemployed agri-professionals have received training. Under the direction of KVVAF, Pune, 544 agricultural agri-projects were started in the state of Maharashtra, by achieving success rate of 53.91%. The importance of hand-holding support, according to the speaker, is crucial for a trainee to successfully launch their agribusiness. He emphasised the hand-holding tactics used by the centre, such as meeting with agripreneurs both at the centre and in their hometowns, selecting a team leader from each batch, using using social media etc

Mr. Kunal Tushar Shelar, the founder of Jadgaon Farmer Producer Company Limited, was the second speaker. Mr. Kunal, who has a Master's degree in agricultural sciences, highlighted that he founded the business with the goal of cutting out the middlemen and giving the farming community actual profits. He covered every of has aspect registration, including number the shareholders, capital share, and procedural activities. Additionally, he emphasized that Jadgaon FPO's primary operation is the production of onion and sweat corn seeds. He concluded by saying that success is mostly dependent on extension work, build a strong farmer network.



Mr. Subhash Kakade, the founder of Kakade Agro Equipment's Master in B.Tech Agriculture Science, spoke before the closing session. He claimed that I had founded my company for the manufacturing of farm equipment with the mission of providing smart farming to smart farmers. I am building my equipment while keeping in mind the type of terrain, canopy, and crops. He highlighted the safety precautions to take when using a sprayer while also displaying farm equipment for various uses. According to Mr. Sanjay, maintaining a sprayer effectively is a difficult work for farmers. He recommended cleaning the filter screen before and after spraying, checking the position of the nozzle before spraying, checking the oil level in the pump, etc., as a means to ensure that farm equipment is properly maintained. The session came to an end with this message.
