I am directed to convey the Administrative Approval of the Government of India for implementation of Scheme "Agriculture Extension" under Green Revolution- Krishonnati Yojna which has four components namely 'Support to Central Institutes/ DOE, Establishment of Agri-Clinics and Agri-Business Centers (ACABCs), Mass Media Support to "Agriculture Extension" (MMSAE) and Support to State Extension Programme for Extension Reforms (ATMA component)' with a budgetary outlay of Rs. 92550.00 lakhs during the Financial Year 2024-25. The Budget Estimate for the FY 2024-25 is basically based on an interim budget and in term of Appropriation (Vote on Account) Act, 2024, the expenditure may be incurred up to about 40-41% of total budget till the approval of final budget.

2. The Component-wise/Head-wise allocation against budget outlays for the FY 2024-25 for each component will be as follows. There shall not be any deviation of funds under any component of the Scheme.

4. As per the instructions of Ministry of Finance, the administrative approval under the component 'Support to Central Institute/DOE' is issued subject to the condition that the Govt. of India Grants to MANAGE for recurring expenditure will be limited to **60%** of its actual projected recurring expenditure during 2024-25.

5. The Quarterly Progress Reports (QPRs) showing physical and financial achievements under each component shall be ensured by the Implementing Agency/Agencies regularly for onward transmission to the Department.

6. The budgetary provision under the ACABC Component during the FY 2024-25 for Training and Subsidy Component will be Rs. 2000.00 lakhs and Rs. 1500.00 lakhs with these components being implemented by MANAGE, Hyderabad and NABARD, Mumbai respectively. The funds under ACABC Component will be released in the form of Grants-in Aid to the Implementing Agency.

7. The Implementing Agencies in respect of all Components of the Central Sector Plan Scheme will be required to furnish Audited Utilization Certificates in the prescribed proforma (GFR 19A) to this Department immediately for the grants released during 2022-23. Provisional UCs may be required to be furnished in respect of funds released during 2023-24 clearly indicating the unspent balance as on 01.04.2024 to enable revalidation of the same for utilization during FY 2024-25, if required.

8. Support to State Extension Programme for Extension Reforms (ATMA Component)

(i) The pattern of funding for the Scheme shall be in the ratio of 60:40 (Centre: State) for General States and 90:10(Centre/ State) for North-Eastern States & two Himalayan States (Himachal Pradesh and Uttarakhand) for all components except Farmer Friend (FF), for which, it will be on 50:50 basis. However, funding for UTs (without legislature) will be 100% from GOI for all components.

(ii) Funds will be released as per demands projected by States/UTs through their State Extension Work Plan (SEWP) after it has been approved by State Level Sanctioning Committee (SLSC) of respective State/ Executive Committee in the DA&FW.

(iii) Monthly Progress Report on physical and financial achievements will be furnished by States/UTs implementing agencies etc. on Extension Reforms Monitoring System (ERMS) portal (http://extensionreforms.dacnet.nic/in/) regularly and no physical progress report would be entertained w.e.f. 01.04.2024, to concerned Scheme Officers of Directorate of Extension, New Delhi. Directorate of Extension will compile these monthly progress reports and submit the same to Department of Agriculture & Farmers Welfare in consolidated form with their comments.
