Administrative Approval for implementation of Centrally Sponsored Scheme" National Livestock Mission-EDEG Component During 2016-17.

We are pleased to advise that Government of India has approved the continuation of the captioned Scheme for 2016-17 with the revised operational guidelines which are available at www.dahd.nic.in. The total budget allocation is **Rs.82 crores**. The State-wise budget in this regard is also enclosed. (Annexure – I)

2.NABARD is the subsidy channelizing agency under Entrepreneurship Development & Employment Generation (EDEG) component of National Livestock Mission. This includes i.e. Poultry Venture Capital Fund (PVCF), Integrated Development of Small Ruminants and Rabbit (IDSRR), Pig Development (PD), Salvaging and Rearing of Male Buffalo Calves (SRMBC). The sub-components of the above are furnished in **Annexure** –**A-I(B)** of the NLM guidelines. (Copy enclosed). The rate of subsidy for various areas and various categories of the beneficiaries are furnished in **Annexure** –**A-I(C)** of the NLM guidelines. (Copy enclosed).

- 3. The other operational guidelines are as under;
- i) Eligible Financial Institutions Commercial Banks, Regional Rural Banks, State Cooperative Banks, State Cooperative Agriculture and Rural Development Banks and such other Institutions eligible for refinance from NABARD.
- ii) Repayment period / grace period;

- iii) Lock in Period of loan 3 years i.e. subsidy can be adjusted to borrowers account after three years.
- iv)Margin Money: RBI guidelines to be followed as applicable from time to time.
- v) Time limit for completion of project would be as envisaged under the project subject to maximum of 12 months from the date of disbursement of first instalment of loan. This maximum period may be extended by 3 months by the financing bank in cases where justification given by the beneficiary is found adequate.
- 4. In terms of point no. 5.1.1(xii) of the Operational Guidelines of National Livestock Mission 2016-17, "in case of beneficiary oriented components, the UID numbers (Aadhar) of the individual beneficiaries may be recorded and included in all project related documents. However, beneficiaries who have not yet received the UID may not be subjected to any disadvantage and in such cases other acceptable ID criteria like BPL register, etc. may be used".

The unit cost assumed for calculation of ceiling of subsidy is indicative only and SLSMC can revise or modify as per the prevailing market price in the area.
- (h) Rearing of male buffalo calves for a minimum period of 24 months.
- (c) All units under 'Entrepreneurship Development and Employment Generation', include provisions for feed and fodder, silage making, biosecurity and healthcare, insurance and other project activities etc.

- An entrepreneur may avail more than one unit (maximum 4 units) of Commercial Unit of 10 ewe / does + 1 ram / buck and; Commercial rearing units (3 sows + 1 Boar).
- (e) No multiple unit will be allowed for other activities under the Component- EDEG.
